Nominations for the election of Office Bearers, Members of the Executive Committee and the two (2) Representatives of the STCML OBA to the Board of Governors as stipulated in Item 12 above, shall be received in sealed envelopes at the Warden's Office, S. Thomas' College, Mount Lavinia, no later than **16.00 Hours, on Thursday, 28th January 2016**, having given 14 clear days Notice before the Annual General Meeting. Nominations for the Posts of Vice President, Hony. Secretary, Hony. Treasurer and STCML OBA Representatives to the Board of Governors should be submitted in Nomination Papers made available at the OBA Secretariat. All Nominations should be duly Proposed and Seconded by two (2) separate Members of the Association, together with the written consent of the Member so nominated. <u>Eligibility of Members to hold Office shall be determined in accordance with the Rules/Constitution of the STCML OBA, duly adopted at the 128th AGM held on 21/02/2014. As per Clause 7(d)(VI) of the Rules/Constitution of the Association, no Member who has served on the STC ML, OBA, Executive Committee for Five (5) consecutive years (without an interruption) shall be eligible for reelection until the lapse of a period of two (2) years.</u>

Nominations for all the posts, except the posts of Vice President, Hony. Secretary, Hony. Treasurer and STCML OBA Representatives to the Board of Governors, can be submitted in self-prepared Nomination Papers which should include the names/addresses/membership numbers of the Proposer and Seconder respectively and the name/address/membership number of the prospective Nominee along with his consent, evinced by his signature. Nomination Papers which do not contain the above particulars or which are otherwise incomplete may be rejected.

Please note that all nominations received before the deadline for submission of Nominations *i.e. 16.00 Hours on Thursday, 28th January 2016* would be displayed on the Notice Board of the Warden's Office from 17.00 Hours to 19.00 Hours. Objections, if any, to any of the Nominations so received would be entertained and decided/ruled upon by the Warden (Ex Officio President) soon thereafter. No objections to any Nominations received would be entertained and/or decided /ruled upon at any time after 19.00 Hours on Thursday, 28th January 2016.
